I. SCOPE OF PURCHASE REQUEST

The American Embassy in **Ankara, Türkiye** requires duty uniforms for the local guard force. The proposal must include delivery to the Despatch in US and Embassy warehouse in Kirkkonaklar, Ankara. The duty uniform requirements and specifications are in the attached SF-18 form and as follows.

II. TYPE OF CONTRACT

This is a firm-fixed price type of purchase order payable entirely in United States Dollars. The offered prices shall include all labor, materials overhead, profit, and transportation necessary to deliver the required items to the American Embassy located in Ankara unless otherwise specified (see FAR 52.228-4 and 52.228-5).

No additional sums will be payable for any escalation in the cost of materials, equipment, or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. All prices shall be in US Dollars.
